7. The Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time the school undertakes to abide then the affiliation & examination byelaws directions issued from time to.
8. That the school will ensure compliance of all statutory equipments like EPF ESI and Labour Laws etc with respect to the school and staff of the school That the school will ensure the Building Safety, Fire Safety. Water Safety. Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authentic from time to time as per the presented term That the school will ensure that all required infrastructure is available with the school before starting classes.
9. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available before starting the classes.
10. That the school will follow the provisions related to fee contained in the affiliation byelaws and will disclose the details of the fee to the students every year before start of session without resorting to any hidden charges in the heads of the fee.
11. That the school will not coerce any student/parent to buy books/stationary uniform from any particular shop
12. That the school shall strive to make efforts for conservation of the environment.



13. That the school will ensure that the school fulfills all essential requirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation byelaws or notified from time to time.

No admission will be taken in the state board pattern class IX TO XII after getting affiliation from CBSE. The State Board school will be discontinued after switchover to CBSE.
